On April 6, 2021, the Advisory Board received a proposal from NDGenWeb to amend a USGenWeb Bylaw. The proposed amendment seeks to strike the requirement that all local sites must provide a query area. By striking as a National requirement, individual States will be free to decide if they wish to adopt the requirement at a State level.

I'm also not sure putting in a requirement for SCs to ensure a bylaw/rule needs to be enforced into every specific bylaw/rule is necessary. But I do understand your feelings and what you are saying.
